The Direct Debit Guarantee

If an error is made in the payment of your Direct Debit, by RSM2000 re Opera Holland Park or your bank or building society, you are entitled to a refund of the amount paid from your bank or building society—if you receive a refund to which you are not entitled, you must pay it back when HMRC Revenue & Customs asks you to. You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
