Instruction to pay your Bank/Building Society

Please pay RSM2000 re Opera Holland Park (OHP) Direct Debits from the account detailed on this instruction subject to the safeguard assured by the Direct Debit Guarantee. I understand that this instruction may remain with OHP and if so, details will be passed electronically to my Bank/Building Society. I consent to allow any of my personal data being used by any third party service provider to process this payment in accordance with the Data Protection Act 1998.

The Direct Debit Guarantee

This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits. If there are any changes to the amount, date or frequency of your Direct Debit RSM2000 re Opera Holland Park will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request RSM2000 re Opera Holland Park to collect a payment, confirmation of the amount and date will be given to you at the time of the request. If an error is made in the payment of your Direct Debit, by RSM2000 re Opera Holland Park or your bank or building society, you are entitled to a refund of the amount paid from your bank or building society—if you receive a refund to which you are not entitled, you must pay it back when HMRC Revenue & Customs asks you to. You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
